1. The FMIS project Management Working Group (FMWG) has received Fund from the Royal Government of Cambodia (RGC) through the Public Financial Management Reform Program (PFMRP) of the Ministry of Economy and Finance (MEF) toward the cost of Financial Management Information System Project, and it intends to apply part of the proceeds of this payment under the Contract for CAM-MEF-PFMRP-FMIS-N002-04 for the following:

Turnkey Contract: Supply, Delivery, Installation, Integration and Migration of Data Center for Financial Management Information System Project (FMIS)

Details of the equipment and services under this tender are provided in Section VI (Schedule of Requirements) of the Bidding Document, .

2. The FMIS project Management Working Group (FMWG) acting on behalf of the **Ministry of Economy and Finance**, now invites sealed bids from eligible and qualified bidders for **Turnkey Contract: Supply, Delivery, Installation, Integration and Migration of Data Center for Financial Management Information System Project (FMIS)**.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures and under the laws and regulations governing public procurement within the Kingdom of Cambodia, in accordance with procedures set forth in the Procurement Manual for Externally Financed Projects/Programs in Cambodia, May 2012. and is open to all Bidders from eligible source countries that meet the following minimum qualification criteria:
 - (i) The bidder (either single bidder or joint venture) must:
 1. Have been operational in the information technology industry for at least 3 consecutive years.
 2. Be financially stable, with an annual gross revenue base of at least US\$2.5 million per annum over the last three (3) financial years, and able to demonstrate access to liquid assets of at least US\$1 million at the time of bidding.
 3. Have been awarded, supplied, installed, integrated, and migrated Data Centers to at least 2 organizations with the same size or amount of this bid.

4. In the case of a joint venture, one of the partners should meet at least 70% of the financial requirement.
- (ii) Each joint venture member other than the partner-in-charge or each subcontractor undertaking a significant portion of work under this contract (25% or greater of the estimated value of the contract) or undertaking major elements of work under this contract (software customization, maintenance, training, installation, supporting) must:
1. Have been operational in information technology or related industry for at least three (3) consecutive years.
 2. Be financially stable, with an annual gross revenue base of at least US\$250,000 per annum over the last three (3) financial years.
 3. Have been awarded, supplied, installed, integrated, and migrated Data Centers to at least 2 organizations with the same size or amount of this bid.
4. Bid Evaluation and Contract Award will be for the entire package comprising of **Part A** (Build Data Center Room), **Part B** (Equip, Install and Operate Non-ICT Equipment including Electrical Work), **Part C** (Equip, Install and Operate ICT Equipment), **Part D** (Integrate and Migrate Data and Environment with Existing Data Center) and **Part E** (Maintenance and Support). Bidders are required to submit a bid for **Part A, B, C, D, and E**; failing which the bid will be treated as non-responsive.
 5. Interested eligible bidders may obtain further information from Financial Management Information System (FMIS) Project, Ministry of Economy and Finance, and inspect the Bidding Documents at the address indicated in para.12 below from **19th December 2017 to 02nd February 2018** from 8:00 a.m. to 11:30 a.m. and 2.00 p.m to 5.30 p.m. (Phnom Penh Time), Monday through Friday, except public holidays.
