Inflation Report, June 2018

A. Domestic Inflation

In June 2018, Phnom Penh Consumer Price Index increased by 0.1% compared to the previous month and 2.9% compared to the previous year. Most of consume goods such as food and nonalcoholic beverages, alcoholic beverages and tobacco, clothing and footwear, housing, water, electricity, gas and other fuels, health, transportation and restaurant increased compare to those in June 2017.

Even though consumer price index was on upward trend, the average growth of the price index in first semester of 2018 was lower at 2.5% compared to that in 2017 at 3.5%. Due to this trend, we can conclude that the inflation in 2018 will remain stable at manageable level base on the modest growth of food and nonalcoholic beverage price level, despite the slightly increased in gasoline price level. By the estimation until December 2018, year on year inflation rate is approximately 2.8% and year average inflation rate is approximately 2.7%.
