#### Objective and Scope of the Assignment

The Royal Government of Cambodia has approved the Cash for Work Program for Rural Development and Livelihood Enhancement Project. The project coordination and monitoring unit (PCMU) is within the Ministry of Economy and Finance (MEF) as the executing agency for the project. Ministry of Rural Development (MRD), Ministry of Water Resources and Meteorology (MOWRAM) and Eletricité Du Cambodge (EDC) are the implementing agencies (IAs).

The Project has four components: Component 1-rural road construction under cash for work program and civil works; Component 2- quaternary canals construction under cash for works program; Component 3-providing low-cost electricity for supporting irrigation system and Component 4-Project coordination and monitoring.

Under component 4, one infrastructure engineer will be recruited in addition to the existing one Senior Infrastructure Engineer. The Infrastructure Engineer, through the effective support to and coordination with the Project technical teams at national and sub-national level; as well as with all Implementing Agencies involved will be responsible for the professional oversight of engineering aspects of quality, cost, quantity and scope, time and safety control of the Sub-Projects' work at the target provinces contracted under the Project. The Consultant will work closely with other PCMU consultants and the staff of PCMU (MEF), along with respective teams. The Consultant will report to the PCMU Senior Engineer, the Team Leader of the PCMU consultants, the Project Manager and the Project Director.

#### **Minimum Qualification Requirements**

Qualified civil engineer having a minimum of Bachelor's Degree in civil engineering or its equivalent and at least 8 (eight) years of professional experience. The Consultant is required to have at least 3 (three) years of public sector project experience in the design; managing construction and supervision of small and medium infrastructure and rehabilitation with similar responsibilities, as mentioned below. Working experience with the Government Implementing Agencies/ Ministries in a professional support capacity and with rural communities, will be an advantage.

The position will be based at the PCMU office at MEF in Phnom Penh with periodic field supervision visits to the Sub-Projects implemented in targeted provinces under the Project. The input will be for 12 months over 14 months, intermittently.

He/she will be responsible for:

- (i) Reviewing proposed Sub- Projects from IAs;
- (ii) Reviewing reports submitted from IAs;
- (iii) Supporting respective aspects of preparation and update of the Project Operations Plan; Financial and Procurement Plans; conducting coordination, problems-solving, monitoring and control of subprojects implementation and progress in contracted Sub-Projects' works in accordance with the Project plans;

#### **Objective and Scope of the Assignment**

The Royal Government of Cambodia has approved the Cash for Work Program for Rural Development and Livelihood Enhancement Project. The project coordination and monitoring unit (PCMU) is within the Ministry of Economy and Finance (MEF) as the executing agency for the project. Ministry of Rural Development (MRD), Ministry of Water Resources and Meteorology (MOWRAM) and Eletricité Du Cambodge (EDC) are the implementing agencies (IAs).

The Consultant will report to the PCMU Senior Engineer; to the Project Manager and the Project Director.

Working experience with the Government Implementing Agencies/ Ministries in a professional support capacity and with rural communities, will be an advantage.

The position will be based at the PIU/MoWRAM office in Phnom Penh with periodic field supervision visits to the Sub-Projects implemented in targeted provinces under the Project Component 2. The input will be for 12 months over 14 months, intermittently.
