1. Brief Note

In the first 10 months of 2022, total national revenue collection reached 20,574 billion riels, equivalent to 92.49% of the 2022 annual budget law, while the total national expenditures reached 20,548 billion riels, equivalent to 66.07% of the 2022 annual budget Law. As a result, the implementation of the national budget received a total surplus of 26 billion riels. After missing to achieve a surplus for last two years (2020 and 2021) due to the Covid-19 pandemic, the implementation of the 2022 national budget began to reach a surplus but was lower than in 2019.

The implementation of the domestic revenue of the Budgetary Central Government (BCG) reached 20,574 billion riels, equivalent to 92.49% of the 2022 budget law, an increase of 26.23% compared to the same period in 2021, of which, tax revenue increased by 26.60% and non-tax revenue increased by 24.29%. Based on the historical trends of revenue performance over the past years, coupled with the recovery of Cambodian socio-economic activities, the revenue performance of 2022 is on track to meet targets set out in the 2022 budget law.

The implementation of the total expenditure of the BCG reached 20,548 billion riels, equivalent to 66.07% of the 2022 budget law which current expenditure reached 13,768 billion riels decreased by 0.61%, while capital expenditure reached 6,780 billion Riels, a decrease of 15.20% compared to the same period in 2021. Overall, the budgeted expenditure for 2022 upholds the premise of minimizing unnecessary spending while shifting the priority to further combat the consequences of the Covid-19 pandemic.

Amid the COVID-19 pandemic, the Royal Government has carefully and effectively managed and utilized the total financing, which is able to sustain the above implementations in a timely manner. The total implementation of foreign financing reached 3,702 billion riels, or 54.25% of the budget law, while the total government deposits amounted to 65 billion riels.

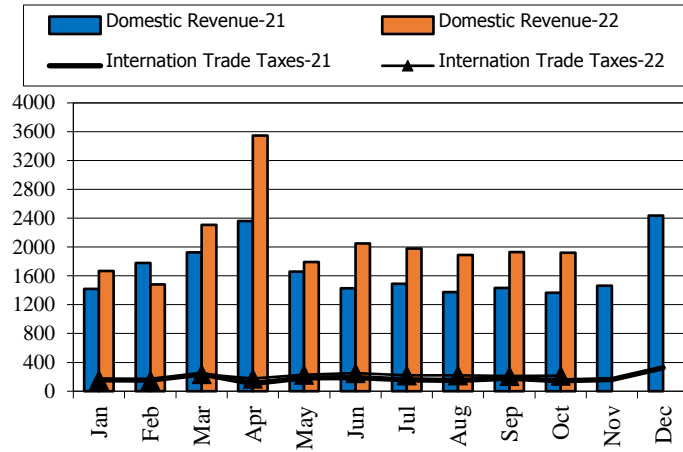

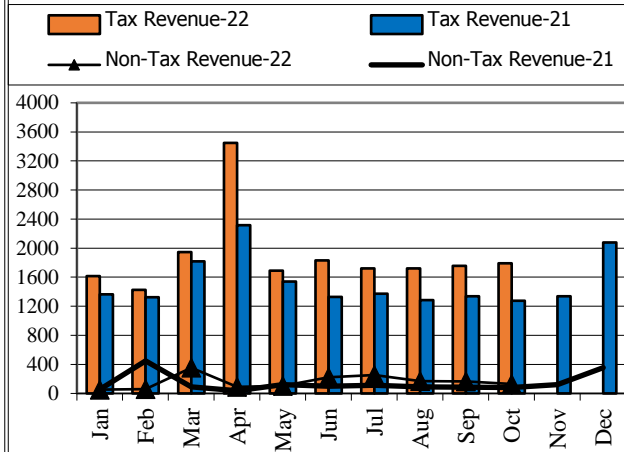

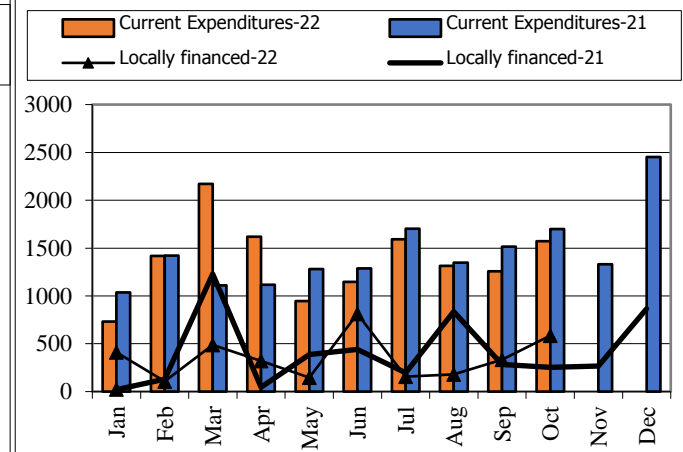
Revenue and Trade Relate Tax 2021-2022



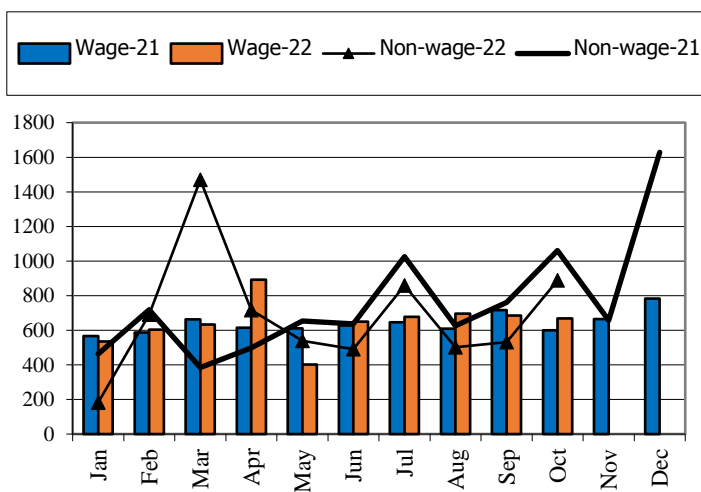
Tax and Non Tax Revenue 2021-2022



Current Expenditures and Domestic Financing 2021-2022



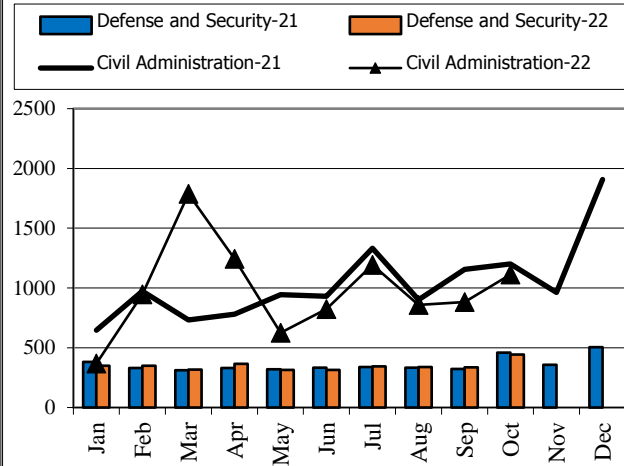
Wage and Non-wage 2021-2022

Multilateral and Bilateral Disbursements 2021-2022

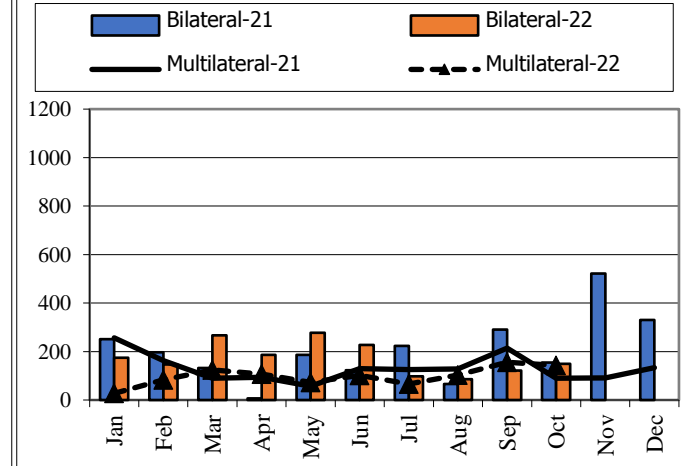
